

## Notice to Candidates: Recruitment Fraud Alert

We have been made aware of unauthorized career opportunities offered by individuals posing as McLaren Engineering Group as part of Recruitment Fraud.

### What is Recruitment Fraud?

Recruitment fraud is a sophisticated scam offering fictitious job opportunities to job seekers. This type of fraud is normally carried out through online services such as false websites, or through fictitious job ads claiming to be from the company.

In this particular case, there have been fraudulent job postings and job offers, purporting to be from McLaren Engineering Group. This scam is primarily targeting potential Work at Home candidates and include use of McLaren Engineering Group's logo. Applicants are typically contacted after responding to a job ad and then asked to interview via an online chat room. In the process, some applicants are asked to provide personal identifiable information. Some applicants have received fraudulent employment offers in addition to fraudulent checks.

**McLaren Engineering Group does not engage in hiring practices of this nature.**

### How to identify Recruitment Fraud?

- All McLaren Engineering Group applicants are required to apply for jobs through our website [www.mgmclaren.com](http://www.mgmclaren.com).
- Fraudulent job offers may involve interviewing in a chat room or may ask for financial information early in the process. McLaren Engineering Group will never use a chat room to interview or ask for financial information.
- All communication from McLaren Engineering Group will be from a **@mgmclaren.com email address only**. In recruitment fraud, it is often a generic account such as *HRDirectorMcLaren@gmail.com*.
